The historic General Store, built in 1907 burned to the ground in an early morning fire on February 28. The store was a popular site for the visitors to the park to gather. It was a total loss.

The General Store has been located in the park for many decades and served both as a general store and a campground registration office.

Alabama Historic Iron-

ny Curry stated, "On behalf of the Ironworks Commission we are saddened at the loss of this well beloved historic structure. In the coming months the Commission and the staff will develop plans for a new general store.'

This International Women's Day had members of the Benjamin Greene community gifted with a session in Yoga presented by Yoga Circle's Stephen Fletcher (assisted with Thai & Adam).

Residents came to the community center to partake in a Yoga chair exercise that started with meditative breathing exercises followed by arm stretches, shoulder rotations, chair poses and others.

Participants learned the fundamentals of staying poised, centered and grounded while performing such, as they relieved unknown stress and worked parts of the body needed to make for a perfect workout.

We also learned about 'Laughing Yoga' as participants joked on how much their bodies appreciated such. We spoke with Yoga in-

structor Stephen Fletcher who told us, "This is a modified portion of the usual Yoga Practice in which the chair exercise gets participants geared towards the more traditional exercises. Mr. Fletcher also informed us about the Holistic approach as well as paying attention to our dietary habits and the way we treat ourselves as well as others, along with practicing thinking positively repetitively.

This particular yoga session garnered an instant fan in participant Tonja Hall. She told us, "I think this is something we need to have consistently at least twice a month because in this one sitting I've found it could help me with my breathing and a way to lessen body tension. Continuing a tradition of excellence, the Hoover Police Explorers recently earned top accolades at state and regional competition, facing off against more than 50 teams. The Explorer Program is a career development program run by the Hoover Police Department that emphasizes academic study, character development and self-discipline.

Current Explorers are: Elijah Ferguson, Molly Rollan, Jackson Fast, Caden Wester, Parker Tolleson, Rashad

Williams and Brooks Boyd. Monday night, Hoover Police Chief Nick Derzis presented the team to the Hoover City Council in an effort to recognize their success.

"Very proud of them. Very proud of the work that they've put in," Derzis said. "A lot of work goes into competition and you can see the results of hard work," he said, referring to the ten large trophies the Explorers were holding.

In January, the Explorers traveled to the University of Montevallo to participate in the ALEAA State Competition. Thirteen teams competed in eight events and Hoover placed in the top three in seven of them. Those events included: Crime Scene Investigation, Disturbance in Progress, DUI Investigation, Unknown Trouble, Traffic Stops, and Burglary Investigation.

In February, the Explorers took part in the Winterfest Southeastern Regional Competition in Gatlinburg TN. Forty-three Explorer posts from across the region participated in four events and Hoover placed first and second in three of four events. Those events were: Uniform Inspection, Domestic Violence and Warrant Service.



Nick Hakes, through his vision for the Compassion Closet, has demonstrated

a profound understanding of the human experience in times of vulnerability. His initiative goes beyond the immediate medical needs of patients and addresses the often-overlooked aspect of their well-being. By providing appropriate clothing, Nick has not only improved the physical comfort of patients but has also helped restore a sense of dignity and normalcy during a challenging time.

Since its inception, the Compassion Closet has become a beacon of hope for those navigating through the aftermath of traumatic experiences. Patients who would have otherwise left the hospital in inadequate clothing are now given the opportunity to depart with self-assurance and comfort. Nick's vision has resonated with both medical professionals and the community, showcasing the transformative power of a simple yet thoughtful initiative. That there is excluded from the territories annexed pursuant to this Ordinance any portion of the territories described above which may be found to be the properties of any person, firm or corporation other than the petitioners or which may be found to lie in an area more than one-half the distance between the old corporate boundaries of the City of Bessemer, Alabama and the corporate boundaries of any other municipality and within an overlapping police jurisdiction of the City of Bessemer, Alabama, and any police jurisdiction of any municipality.

7. That a copy of this Ordinance shall be published in a newspaper of general circulation in the City of Bessemer, Alabama and filed in the probate court of Jefferson County, Alabama.




