Fountain Building Supply Celebrates 75 Years in **Business**

The city of Bessemer was 62-years-old when Fountain Building Supply was established in August of 1949. 75 years later, Fountain Building Supply is celebrating their diamond anniversary.

Fountain Building Supply, an anchor in downtown Bessemer for 75 years, has constantly served and met the needs of their customers in Bessemer and throughout the Bessemer Cut-Off. They have grown from one building to two buildings and a large lumberyard.

The week of August 1 Fountain's is planning 75^{th} anniversary а celebration which will include giveaways, snacks and drawings.

Fountain's sells everything from ice scrapers to doors and windows. People also shop at Fountain's for hardware supplies, flooring, paint, plumbing and electrical supplies, cabinets, custom-cut kitchen and vanity countertops, swings, rockers, lawn and garden

supplies, lumber and pest control products.

Originally located on the corner of Seventh Avenue, North and 20th Street, North the hardware store new was known as Central Hardware. Several years later, Norman Fountain purchased the business and renamed it Fountain Building Supply. His wife Lizzie Fountain was a fixture at Fountain's for decades.

In the late 70s, Norman's son-in-law, Sidney Howard and his wife, Lynne took over the business and moved Fountain's across the street to their present

location at 731 20th Street, North. The building was originally Bruno's Grocery Store. Howard was responsible for expanding the building materials department and working closely with homebuilders.

Today, Curry and Leigh Howard own and operate the family-owned business and Curry is the third-generation owner.

The family is looking forward to a promising future when their son, Curry Lee Howard, fourth-generation the owner takes over the business which remains a destination hardware and building supply store.

Bessemer Approves Moratorium on Used Tire **Sales Businesses**

WESTERN STAR STAFF At the April 2, 2024 meeting of the Bessemer City Council a moratorium on the issuance of business licenses under the City of Bessemer's Business

License Code was imposed on used tire sales businesses. Councilman Jarvis Collier made a motion to

approve resolution No. 164-24. Councilwoman Carla Jackson seconded the motion. The motion carried

Councilman Chester W. Porter initiated the action

regarding the growing concern over the number of used tire sales shops throughout the city of Bessemer. Porter said, "The purpose of the moratorium is to control the number of used tire sales businesses in the city.'

The city of Bessemer is charged with the responsibility of setting policies and to enact regulations that improve the quality of life for the citizens of Bessemer.

The Bessemer City Council has determined that the over development of used tire sales businesses within the city limits

would be detrimental to the city's development and effectively limit the ability of the city to attract diverse types of businesses.

City Attorney Aaron Killings stated, "The city has been inundated with tire shop businesses. He elaborated that the moratorium is for all future tire shop businesses seeking to have businesses in the city."

The moratorium will create a stable environment allowing revisions to the city's zoning ordinances to be considered and adopted in an orderly manner.

City of Hoover asks Residents to make sure they report all missed trash pickups

Thursday, April 25th marked one month since Hoover's garbage collection provider, Amwaste, started a new route schedule promised to make service more efficient.

Instead, just the opposite has happened.

Between March 25th and April 25th, Amwaste missed a reported total of 2,051 pickups throughout the city. That's 421 more reported misses than in the entire months of December, 2023 and Januarv. 2024 combined - a time that left many residents frustrated during the holiday season.

While City leaders engage in daily communications with Amwaste, urging them to swiftly correct the problems, they also apologize to residents for the misses.

"We are truly sorry and extend our apologies to the residents who deserve a quality level of service from this contractor," says Ken Grimes, Hoover City Administrator. "For Hoover, with over 28-thousand residential homes, we acknowledge that many are receiving good trash service twice a week and on time. But the number of reported misses is unacceptable citywide. City staff members are doing all they can to get misses serviced, rectify route problems of Amwaste and raise the confidence

Grimes says there is a way residents can help, too. He notes that it is imperative for residents to report when they have a missed pickup and to urge their neighbors to do the same through the city website, www.hooveralabama.gov or through several other methods the city provides.

"It is imperative that we get an accurate accounting of all the homes that are missed on a daily basis, whether curbside or backdoor service," Grimes explains. "A reported miss provides data and logistical information such as the street address and whether a single home, street or neighborhood was missed. Reporting a miss at this point in time is the absolute best way our citizens can help us solve the problem."

Hoover is not the only city facing challenges with Amwaste. The leaders of Homewood, Mountain Brook and Vestavia Hills report similar problems, along with officials in Jefferson County. Hoover retained Amwaste as a result of the city's website.

Cahaba Solid Waste Disposal Authority, a group of cities in the Birmingham metro that have pooled their resources in an effort to get the best and most competitive services for garbage collections. But as a result of being a CSWDA member, Hoover must follow certain protocols detailed in that contract. Still, city leaders say they are looking for alternative methods they can use that would ultimately hold Amwaste financially accountable if missed pickups continue.

"I want to assure the citizens of Hoover that Amwaste knows they have problems. We are working daily to help rectify these challeng-Hoover deserves es. top-notch trash service and we will get there," Grimes added.

In the Garden

Admittedly, I'm quite envious if you are as I've tried my whole life to be. Mornings are lovely, and even lovelier still if you are a believer who invites the presence of the Lord to join you as you sip your coffee or tea, watching the sun rise in the sky and the world wake up alongside it.

"In the Garden" was written by C. Austin Miles in March of the year 1912. A pharmacist whose true passion was music, Miles left the medical field after he published his first gospel song with Hall-Mack Company. He later went on to become the editor and manager of that music publishing company and served them for 37 years.

Described as an affable man with an extraordinary wit and sense of humor, Miles was said to always have a small flower pinned to his lapel. One of his favorite hobbies was photography, and he had built his own darkroom for developing film. On one such day that he was waiting for film to develop, he opened up his Bible as he often did for inspiration for his songwriting. Picking up his Bible with no particular passage in mind, the pages fell open to John 20 where it describes the story of Mary com-

Are you a morning person? him in the tomb, she was over- well. Have you ever heard "the joyed to find Him standing nearby and was able to recognize him when he spoke to her.

Imagining himself into that glorious moment of meeting in the garden, he described that he gripped his Bible, his muscles tense and vibrating. He recorded himself thinking, "This is not an experience limited to a happening almost 2,000 years ago. It is the daily companionship with the Lord that makes up the Christian's life." Afterwards he penned a poem in his inspiration from this story as told in Scripture, which was later set to music and became the well-known and beloved hymn, "In the Garden."

Regarding himself, Miles said: "It is as a writer of gospel songs I am proud to be known, for in that way I may be of the most use to my master, whom I serve willingly although not as efficiently as is my desire.

Are you familiar with the calm of a peaceful morning? Miles must have been, because as he writes of moments when "the dew is still on the roses" it's hard not to imagine early, warm sunlight streaming through the leaves as the world awakes. What peace one can find in those quiet moments - and what peace our ing to the garden to visit the tomb Lord affords to us as believers in munitymedia.com. I would love of Jesus. But instead of finding our quiet moments with Him as

sound of His voice" that "is so sweet the birds hush their singing"? If you ever have, it is without a doubt that "the melody that He gave to [you] within [your] heart is ringing.

I read an article recently that asked an alarming question: "Is the Most Digitally Connected Generation Disconnecting from Their Faith?" 


